Il sito si situa nel settore centrale del vallone di Chavacour, nel comune di Torgnon, ed è costituito da una piccola piana circondata da boschi di Larice e chiusa verso monte da una suggestiva parete rocciosa; al centro del bacino, il Torrente Petit Monde serpeggia formando una vasta zona umida alimentata anche da apporti laterali di ruscelli e sorgenti.
